Participants

All persons of legal age, excluding members of the jury and SOTERMUN managers, may participate. Participation in this competition implies full acceptance of the present rules.

Theme

Submitted photos entered into the competition shall be related to the world of work, under the idea or concept of "Decent work for Decent Life".

The organisation reserves the right to only accept works that correspond to the theme established and that meet a minimum set of technical requirements.

Sending the works

Each contestant may send a maximum of three photographs. They should be sent by email to sotermun@sotermun.es In addition to the photo(s), the contestant shall provide the following information: first name and surname, pseudonym of his/her choice, address, town/city and postcode, telephone number and email address. As well as, when considered, the title and a brief description of the photograph.

The photos shall be presented in JPG format, with a size of 30 cm on the largest side of the photo and a resolution of 300 dpi. The photos entered into the competition shall not have been previously published in any printed or online magazine, book or publication. Nor shall they have been the object of any other photographic prize.

Submission deadline

The deadline for the submission of the photos is 15 September 2021 at the latest.

Selection of photos and jury's decision

The Jury will select the winner on 29 September 2021 and the prize will be awarded in a public ceremony held on 7 October 2021 by the Unión Sindical Obrera (USO) on the occasion of the World Day for Decent Work, promoted by the International Trade Union Confederation (ITUC).

Jury

The jury will be composed of members of SOTERMUN's Executive Board as well as persons with experience in the world of image and communication.

Prize

The prize will consist in €500 for a single winning photograph. Among the awards, there is the possibility of two other secondary prizes, regarding the quality of the photographs. One of the secondary prizes will be an award of €250 and the other of €150.

Publication of photos

The photos presented may be used on SOTERMUN's and USO various dissemination platforms. Once the winner is announced, the finalist photos will be published in SOTERMUN's, *Ser Seres Solidarios* magazine and on its website www.sotermun.es.

Rights to the photos

SOTERMUN and USO reserve the (non-exclusive) right to freely expose and reproduce any of the participating photographs.

The participants will take responsibility for the publication of their images by third parties. On the other hand, the organisers undertake to indicate the name or pseudonym of the author each time his or her photograph is reproduced.

Data protection

In accordance with the provisions of Regulation (EU) 2016/679 of 27 April, or the General Data Protection Regulation (RGPD), by filling in the corresponding form and accepting these rules, the participant in the competition gives consent to the processing of personal data voluntarily provided by himself/herself (identification, contact and, where appropriate, economic data for the delivery of prizes), by SOTERMUN, with NIF/CIF G81052151, that will take the responsibility for the processing.

The legal basis that legitimates the processing of the participant's data, is their consent, and the purpose is the proper registration and participation in the contest, as well as the management and delivery of prizes. The data

may be kept for a period of 5 years, to comply with the obligations arising from the management of the contest, unless the participant requests its deletion.

The participant's data will not be transferred to third parties except in the case of legal obligations, and may only, and if appropriate, be transmitted to administrations, entities or bodies that contribute to managing the proper payment and delivery of prizes, if the participant is proclaimed the winner. In the event that such transmissions lead to the existence of international transfers of data, due to the origin of the participant, to countries outside the European Economic Area, the participant consents to such transmission being carried out in his/her own interest or benefit. In the event that the recipient country does not offer reciprocal guarantees to those provided by the GDPR, the data exporter and importer shall observe appropriate security measures to ensure the integrity, availability and confidentiality of personal information.

Likewise, it is informed that the participant may at any time exercise his/her rights of access, rectification, suppression, limitation, opposition and portability, by means of a request addressed to Plaza Santa Bárbara, 5-6 Planta, 28004, Madrid, or free of charge to the e-mail sotermun@sotermun.es. The request must be accompanied by a photocopy of the fiscal identification number or an equivalent supporting document. In any case, the participant has the right to revoke the consent given and to lodge complaints with the Spanish Data Protection Agency (AEPD).
